#### **Increasing PAC Participation**

Holtzman Vogel

- Raffles, sweepstakes, and auctions are methods to build excitement around participating in the PAC.
  - Definitions of each are important to understand how they're regulated.
- When held to support the PAC, the full price paid for every ticket or sale is a contribution to the PAC.
- Like any other contribution: only restricted class

## Headline, Enforcement Risks

#### Holtzman Vogel

- Major federal trade association's PAC violated one-third rule, restricted class limits through raffles; public FEC enforcement and penalties via conciliation agreement
- U.S. Senate candidate Dave Lindstrom's campaign committee allegedly violated state law by raffling a Kansas City Chiefs jersey signed by Patrick Mahomes.
  - "A raffle conducted by an entity other than a qualifying nonprofit organization would be considered a lottery," . . . noting that lotteries are prohibited under Kansas law with an exception for the state-run lottery.
  - "The campaign still plans to give away the autographed Mahomes jersey, but it will no longer require a contribution— <u>a change that will likely resolve the legal issues</u>."

## • Outreach to new potential donors may come with downsides.

- Your restricted class and executives may question the purpose and activities of your PAC.
- Always good to have a PAC FAQ messaging ready.
- PAC Board should consider "Guidelines" on contributions.

## Sources of Law to Consider

- Federal Election Campaign Act (for federal PACs)
- State campaign finance laws (for non-federal PACs)
- State gaming laws
- State sweepstakes laws
- State regulation of auctions (rare)
- Federal and state tax law

#### **One-Third Rule**

#### Holtzman Vogel



- Remember: For federal, connected PACs, a connected corporation may provide gifts or prizes if it observes the one-third rule.
- One-Third Rule: The value of gifts or prizes can not exceed one-third the amount of the resulting PAC contribution(s).
  - PAC reimburses connected corporation for overage
  - Food, drinks, and facilities are not subject to the one-third rule.

#### **One-Third Rule**

## Holtzman Vogel

#### • Examples:

- A trade association spends \$300 in treasury funds to purchase a TV set as a raffle prize. Sales of
  raffle tickets raise \$600 in contributions to its connected PAC. Since one-third of the amount
  raised (\$200) is less than the cost of the prize (\$300), then the PAC should reimburse the
  association for the \$100 difference.
  - If the PAC raises \$900 in contributions, then one-third of that amount (\$300) is equal to what the association spent on the prize, so no reimbursement is necessary.
- A corporation wants to hold a drawing for a grand prize valued at \$2,500 for any donor to its connected PAC over the previous 6 months who maintained a contribution by payroll deduction. So long as the PAC raised at least \$7,500 during the previous <u>12-month</u> period, then no reimbursement from the PAC to the corporation is required. AO 1999-31.

#### Raffles

- Contest rules should be written and available to participants.
- A PAC may not accept prizes or entertainment donated by corporations other than the connected organization or its affiliates.
  - Exception for trade associations.
- Like any other contribution: only PAC-eligibles may enter a PAC raffle.

## Raffles

#### Holtzman Vogel

- Every ticket buyer or auction winner (ie, <u>donor</u>) should fill out a donor response form.
  - This also applies to online raffles conducted via password-protected PAC websites.
  - Cash <\$50?
- Special tax considerations: For a raffle, the PAC pays taxes on the proceeds <u>unless</u> the PAC makes it clear on the tickets and at the event that the money raised will support political goals.
  - Prize may be taxable to the winner
  - If \$600 or more, and at least 300x of the wager, PAC must complete a W-2G (Gambling Winnings)
  - Withholdings in some instances where prize is >\$5,000
- If the raffle underperforms 1/3 rule may come into play.

## State Gaming Rules - Prohibitions

- Any contest must comply with state gaming laws, particularly raffles.
  - For this reason, an <u>online raffle</u> spanning multiple states is effectively an impossibility
    - But *could* work at a single location where legal, for instance an off-site corporate retreat
  - Some have absolute prohibitions on a ticketed raffle by a political committee (e.g., California, Florida, Massachusetts, New York, Texas)
  - Can still hold a sweepstakes, auction
    - Option to hold a skill game, e.g., a reading comprehension quiz, for an entry.

# State Gaming Rules – Prohibitions (cont).

- Some states allow political committees to hold a raffle, but require an <u>advance</u> permit (e.g., Illinois)
  - Every new contest requires a new permit
  - File detailed information about the contest to apply for permit, like date, location, prizes, and responsible PAC officers
  - Sometimes, also file raffle report at the conclusion of the contest

# State Gaming Rules – Prohibitions (cont).

### Holtzman Vogel

- Alaska a class of its own. With an advance permit, your PAC can hold:
  - "Animal classic": a game of chance in which prizes are awarded for the correct guess of which numbered or colored hole on a wheel a rat, hamster, gerbil, or other rodent enters as the wheel is slowly rotated.
  - "Dog mushers' contest": a contest in which prizes are awarded for the correct guess of the racing time of a dog team or of team position in the race.



#### Sweepstakes

- Legal in all 50 states.
- No purchase or entry fee required.

## Auctions



- Full value of purchase is a contribution
- Source of the auction prize?
- Like any other contribution: only restricted class
- One-Third Rule applies
- Rarely: some states restrict auctions to "sealed bids" or require hiring an auctioneer



## **Necessary Disclaimers**

### Holtzman Vogel

- Solicitation disclaimers still applicable to this fundraising through a different form. For federal PACs, this means:
  - Paid for by statements
  - Contribution and source limitations
  - Best efforts statement
  - Statement of political purpose
  - Suggested amounts and non-coercion
  - Tax-deductibility statement
