Public Affairs Management

Focus:

Mid-level public affairs professionals

Goal:

Strengthen understanding of and expertise in political action committees or grassroots advocacy

 Specialization: Must specialize in one area (can complete multiple certificates and earn both specializations)

• Focus:

Mid-level public affairs professionals

Goal:

Strengthen understanding of and expertise in government relations and lobbying

Specialization:

No specialization, but ability to select government relations or lobbying focused coursework

Focus:

Current and rising leaders in public affairs

Goal:

Strengthen knowledge of best practices in public affairs management and enhance expertise in leading an integrated collaborative and strategic public affairs function

• Specialization:

No specialization, but ability to select electives

Program Overview: Experience and more

PAC & Grassroots Management

- Required Experience:
 2 years in public affairs (not required to be PAC-or grassroots- specific)
- Completion Window:2-3 Years
- When to Apply:
 Prior to or within 30 days after attendance at a certificate-eligible program

Government Relations & Lobbying

- Required Experience:
 2 years in government
 relations, lobbying or
 advocacy (or one full year as a legislative or agency staffer)
- Completion Window:2-3 Years
- When to Apply:
 Prior to or within 30 days after attendance at a certificate-eligible program

Public Affairs Management

- Required Experience:
 - 7-10 years in public affairs with demonstrated responsibility for function management, crossfunctional leadership and/or strategy-level decision-making for public affairs
- Completion Window: 3-5 Years
- When to Apply:

 Prior to or within 30 days after attendance at a certificate-eligible program

Certificate Basics

- Three programs: PAC & Grassroots Management, Government Relations and Lobbying, Public Affairs Management
- Webinars are 1 credit, workshops are 2 credits, signature events are 3
 -6
 - Must attend webinars and workshops live recordings don't count
- Not tied to your position you don't have to start over if you change jobs
- We send you a framed physical certificate upon graduation
- As of October 1, 2023 \$199 fee

Applying

- Fill out NEW online form
 - Name, organization, summary of job history to ensure requirements are met, contact info
- I'll review it and if everything looks good, you're in!
- Any events taken within 30 days of application date will count
- Open to members and non-members

PAC & Grassroots

25 Credits - \$4,500 - \$6,000 - 2 years experience - 3 years to complete

Specialization – 15 Credits

- Can choose PAC or Grassroots, or eventually do both
- Get credit through webinars, workshops, "signature events" – must go to Advocacy or PAC Conference

Community – 5 Credits

- Not like the others interacting with the community instead of attending events
- Can speak at events, post on Council Connect, serve on an advisory committee, write a tip sheet/newsletter, or submit documents

Compliance – 5 Credits

- Webinars and workshops specifically on compliance topics
- Biannual summits with Ken Gross
- Learn how not to go to prison



Government Relations & Lobbying

25 Credits - \$3,800 - \$5,000 - 1*- 2 years experience - 3 years to complete

Specialization – 16 Credits

- Single track rather than dual track like PAC & Grassroots
- Open to Hill or federal/state regulatory staffers with one full year of experience
 - Otherwise, two years of public affairs experience
- Must attend the Advocacy Conference or Government Relations and Policy Conference

Community – 5 Credits

 Can speak at events, post on Council Connect, serve on an advisory committee, write a tip sheet/newsletter, or submit documents

Compliance – 4 Credits

- Webinars and workshops specifically on compliance topics
- Biannual summits with Ken Gross

Public Affairs Management

30 Credits - \$3,200 - \$4,400 - 7 years experience - 5 years to complete

Core – 12 Credits

- Single track management specific webinars and workshops
- Must attend Public Affairs Leadership Summit
- Can get credit from Spring Executive meeting

Compliance – 4 Credits

- Webinars and workshops specifically on compliance topics
- Biannual summits with Ken Gross

Elective – 8 Credits

- Webinars and workshops that aren't managementspecific
- If you have graduated from Public Affairs Institute, you get 5 elective credits

Leadership/Community – 5 Credits

- REQUIRED: Speaking, creating a resource (~500 words)
- OPTIONAL: Council Connect posts, documents, serving on advisory committee, contributing to newsletter
