Western Alliance Bank (WAL)

- ~\$81 billion in assets commercial bank & mortgage company headquartered in Phoenix, Arizona
- 3,532 employees across 30+ states but most are in AZ, CA & NV
- 60 offices/branches
- Government Relations function was started March 2022

WABPAC

- Launched September 2022
- Current Restricted Class = 1,684 employees + WAL Board of Directors
- 177 employees (10.5%) and entire board participating
- 2024 Election Cycle

•	Raised	\$477,028
•	Spent	\$435,750
	Cash on Hand	\$127,778





Communications Approach

- Educate First and Always
- Survey and adapt to findings
- Be Creative



Focus on Education First and Always

Situation at Launch

- Most employees unfamiliar with corporate PACs (the "what")
 - Misconceptions to refute
- Concerns about the "who"
- No inherent understanding of the "why"

Tactics

- Website for eligible employees heavy on education
- Initial email series focused on educating only last in series asked for contribution
- In-person launch event and solicitation at headquarters with CEO/executives




How do your people want info?

- Survey of restricted class Q1 2023 work with Sagac Public Affairs
- Findings regarding messaging:
 - Employees want the PAC to be bipartisan
 - Most responsive to messaging that is team-oriented or about protecting the bank
 - Non-donors were most responsive to PAC Charity Match messages
- Findings regarding solicitation timing/channels:
 - Emails, newsletters, intranet, webinars, in-person group meetings
 - March most popular month but September and December good too
- Findings regarding benefits:
 - Charity match, special events, political info, WABPAC-branded items
