- 119th Cmte assignments: Banking, EPW, HELP, Aging




Building Relationships with new Members

- Early engagement is critical
 - Start working with candidates during the election cycle
 - Visits to district sites make a big impact
 - Spend time understanding issues that interest Members
 - Many new Members are former local & state legislators with records on issues
 - Others have business, education, and other leadership experience
- Working with new office staff
 - Some new Members bring campaign staff or local advisors to lead DC office
 - Others hire seasoned Washington DC teams
 - Staff and office dynamics are a barometer of new Member success
- Help before asking for help
 - Engage with network of staffers who may be looking for opportunities & offices needing talent
 - Educate and inform first
 - Understand alignment with new Member priorities and where you have complimentary interests

Tech as a Catalyzer and a Subtext

- Energy: Data centers representing the biggest new source of energy demand
- Tax: IRA repeal; R&D deduction; CHIPS Act tax credit; advanced manufacturing tax credit
- Immigration: High-skilled immigration GOP internal debate
- Defense: DOGE and doing more with less (or more with more!)

Legislative Horizon

- Senate Confirmation process
 - Committee hearings begin next week
 - National security and non-controversial nominees traditionally receive quick consideration
 - Controversial nominees and non-Cabinet appointees take longer
- Reconciliation
 - Ongoing discussions between Congressional Republicans and President-elect Trump on process
 - Process requires passing budget with Committee instructions
 - Senate Byrd Rule limits scope of what is included
 - Traditionally rulings of Parliamentarian stand does that tradition continue?
- Debt Limit
 - Treasury Department begins extraordinary measures in short order
 - Ultimately likely to be addressed in a bi-partisan fashion as has been the case historically
- Federal Funding
 - Current continuing resolution funds federal government through March 14th
 - FY '26 process will begin while the FY '25 process is resolved

Legislative Horizon II

- National Defense Authorization Act
 - FY '25 was 65th year in a row a defense authorization was enacted
 - Traditionally open House amendment process with limitations on germane items
 - Senate historically has added more tangential items
- Bi-partisan Issues
 - Farm bill reauthorization
 - Artificial Intelligence
 - Counter China
 - Surface Transportation
 - Drug pricing/health care costs

- Some parts of the legislative process will be highly partisan others will be bi-partisan
- Early engagement and preparation to ensure Members are champions for your issues is critical
