# **O-I Achieves Federal Wins, Reforms, and Reductions**

O-I achieved unprecedented successes in Washington in 2015. O-I's accomplishments were directly supported by the efforts of colleagues from around the U.S. to elect and communicate with legislators who are pro-manufacturing and who support the company.

### O-I Gains AMT, R&D Wins

Legislation passed by the Congress in December allows O-I to secure refunds on years of alternative minimum tax (AMT) payments beginning in 2016. As a result, O-I will receive substantial tax refunds totaling \$24 million over the course of five years, which can be used to reinvest in the company. Securing these AMT re-payments has been an important and long-standing priority of O-I for many years. Many Members of Congress who represent O-I employees weighed in on behalf of the company's position on this issue.

The same bill made the research and development (R&D) tax credit permanent. The R&D tax credit is valued at over \$2 million annually to O-I. This provision helps manufacturers like O-I innovate, invest and compete.

O-I also achieved the extension of the "CFC look through," which protects the company from millions in tax cost and is an important component in O-I's tax planning.

Government Affairs, coordinated O-I's efforts on these issues over the past year.

These positive outcomes for O-I are the product of years of collaborative efforts by O-I's Tax and Government Affairs departments.

#### **Cadillac Tax Delayed**

December legislation delayed the implementation of the Affordable Care Act's "Cadillac Tax" from 2018 until 2020. This tax on employee healthcare plans would have impacted O-I by nearly \$6 million per year. Manufacturers, like O-I, have always had healthcare benefits as an important component of their compensation for employees – in fact, at least 97 percent were doing so before enactment of the ACA, according to the National Association of Manufacturers (NAM). Healthcare and pension costs will remain a top concern for O-I for years to come.

#### **Ozone Standard Finalized**

The Obama Administration finalized a rule that sets a new ozone standard for the U.S. This rule lowers the standard to 70 parts per billion (ppb) from the already stringent standard of 75 ppb. O-I, in partnership with the Glass Packaging Institute (GPI) and the NAM met with Members of Congress in opposition to the rule. The worst-case scenario for manufacturers – a potential standard as low as 60 ppb – was avoided. While this rule is now final, O-I and other manufacturers will continue to make their voices heard on proposed emissions policies.

#### **Soda Ash Reduction Supported**

O-I coordinated with the Glass Packaging Institute (GPI) and the Beer Institute to support federal legislation that temporarily reduces the royalty continued page 3

producers must pay for sodium carbonate (known as "soda ash") mined on federal lands. This issue is significant because soda ash is essential in the manufacture of glass containers. The majority of soda ash mining operations in the U.S. occur on land leased from the federal government located primarily in the Green River Basin in Wyoming. For every ton mined, a royalty rate or "fee" must be paid. Reducing the royalty rate is an important step in supporting U.S producers who continue to lose market share to Chinese-manufactured artificial soda ash. **Shawn Welch**, Vice President Sales and Marketing, attended the Beer Institute's annual meeting in Washington, D.C., and highlighted this issue along with other federal issues.

#### **EPA Waters Rule Postponed**

O-I was active in 2015 in addressing the EPA's recently proposed Waters of the United States (WOTUS) rule. Members of Congress heard important input from Plant Managers and regulatory

staff during O-I plant visits. The company focused on the potential impact of this rule on operations in the U.S. While O-I plants already go through the appropriate permitting process, this rule would add unnecessary regulatory steps for U.S. manufacturers. The GPI and NAM were important industry association allies on this issue. In a surprise decision, the U.S. Court of Appeals for the Sixth Circuit postponed action on this rule in October.

#### **Dodd-Frank Reformed**

Under the U.S. "Dodd-Frank" law, manufacturers had to meet certain financial requirements as derivative end-users. O-I supported industry efforts to change the reporting and certifying conditions needed to meet the end-user exception. PL 114-1, adopted in January 2015, included language that made changes to reporting requirements, easing administrative burdens on internal treasury staff. The changes are expected to significantly reduce the administrative burden to O-I from this rule.

# **O-I Scores Wins in Key States**

O-I achieved several important successes in 2015. All of these were made possible by the work of O-I colleagues from multiple departments and plants. The company was active in 2015 in most of the states where plants are located. This report highlights the most significant activity.

## CALIFORNIA \$48 Million in New Fees Held Off



O-I, in its lead role supplying the California beverage industry and an end user of its post-consumer glass, is a fierce defender of the California Beverage Container Recycling Fund (the container deposit program).

Early in 2014, Governor Jerry Brown proposed up to \$48 million in new fees on glass companies and their customers, on top of the \$9 million currently paid annually, in order to help shore up finances of the container deposit program. O-I worked with the Glass Packaging Institute (GPI) and glass industry union leadership to defeat the proposal in a unanimous committee vote.

Despite its defeat in 2014, California's recycling agency sought to revive the proposal this past year. With the support of North America Controller Mike Korte, Procurement Manager Mike Duhammel, and Plant Managers Pedro Tchmola and Kelly Young, as well as staff at each of our California plants, O-I Government Affairs was able to curb agency interest in reviving the fee increases by highlighting the economic and environmental value of glass, while also arguing that the state did not have a good handle on its program finances and that savings could maintain the solvency of the program without resorting to fee increases. O-I expects another run at a fee increase in 2016.

O-I also worked with the GPI and environmental groups to ensure that glass beverage containers were properly treated under the California Toxics in Packaging statute, which addresses end of life

handling of packaging. O-I and others argued that studies were unanimous in showing glass is safe in landfills and should not be within the scope of the statute. In June, the California Assembly passed the legislation by a wide margin. Action on the bill then moved to the California Senate, where an initial hearing was held. Efforts on the bill will continue in 2016.

#### **MARYLAND**

# Possible New Source for Recycled Glass for O-I Mid-Atlantic Plants



O-I was a lead supporter in 2015 of a bill to create a model beverage container deposit program in this

state. O-I now benefits from Maryland curbside glass processed in Pennsylvania. Legislation was introduced and hearings were held spring of 2015. A summer study was conducted in order to further refine how a deposit program could work for Maryland, with work continuing on this proposal into 2016.

# **OHIO**Tax Increase Defeated



Governor John Kasich proposed sweeping tax reform for Ohio in 2015. Unfortunately, the proposed restructuring would have meant an \$8 million annual increase in

O-l's state tax burden. O-l was successful in defeating the proposed hike in corporate taxes, including a tax on both internal and external services provided to our global operations through our headquarters. Working closely with U.S. Government continued page 5

Affairs Manager **Mike Smaha**, Tax Department Leaders **Julie Flannagan** and **Ryan Smith** were critical to O-I's ability to explain to the state legislature O-I's importance to the Toledo area economy and the negative impact on the company. O-I coordinated with other companies on this proposal through the Ohio Chamber of Commerce and the Ohio Manufacturers' Association.

A number of lawmakers were critical to the victory, including State Senators Randy Gardner (Bowling Green) and Troy Balderson (Zanesville); State Representatives Tim Brown (Bowling Green), Brian Hill (Zanesville), and Barbara Sears (Monclova Township); and House Speaker Cliff Rosenberger. North America President **Sergio Galindo** recognized the leadership of these legislators in supporting a budget, which "did not raise the commercial activities tax, the sales and use tax, or add a tax to professional services." O-I will continue to work with legislators to prevent further tax increases in 2016.

# **Bottle Deposits and Gross Receipts Watched Closely**



Aside from watching the recent reforms to the state's bottle deposit program and how those changes could impact O-I, the company is

also closely monitoring proposals to raise the state's

gross receipts tax, which could bring a substantial increase in taxes for manufacturers.

# VIRGINIA Workforce Training is Key



A major challenge across all of manufacturing is the recruitment and training of new employees for highly skilled

positions. Human Resources staff Karen Morris,
Tanja Chappelle-Logan and Brian Piezer worked
with Mike Smaha to highlight the skilled workforce
needs of the plants. Plant Managers Chris Tonk
and Calvin Griffin helped lead efforts to highlight
O-I's contributions to the Virginia economy over
the past two years. O-I received substantial grants
for job training at our plants and will continue to
work with the Virginia Manufacturers Association to
expand workforce training funds.

# **WASHINGTON**Cap and Trade Could Impact O-I



O-I welcomed the new employees in Kalama to the company in 2015 and O-I Government Affairs got right to work addressing the state's

emissions cap and trade program. O-I expects action on this measure to continue well into 2016.

We have an opportunity in the year ahead to build on the successes of 2015. Together we can help create new opportunities and deliver improved results for O-I.


