- Issue-Focused



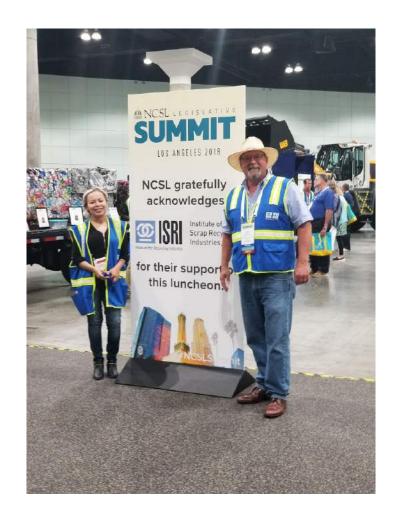

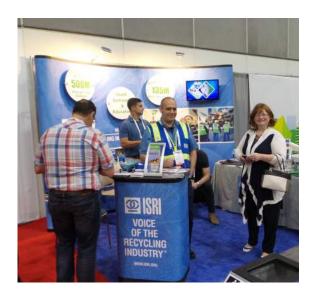
