The firm does not make corporate political contributions to candidates or political parties.



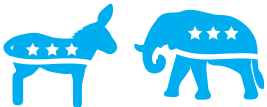
## Our PAC's Role

Cobham employees are free to give more or less than the suggested guideline, or not at all, without reprisal. Only U.S. citizen or foreign citizen admitted for permanent U.S. residence may contribute to Cobham PAC. Federal law requires Cobham PAC to make its best effort to report to the Federal Election Commission the name, address, occupation and name of employer, date and amount for each individual whose contribution exceeds \$200 per calendar year. Contributions to Cobham PAC are not deductible for federal income tax purposes.
