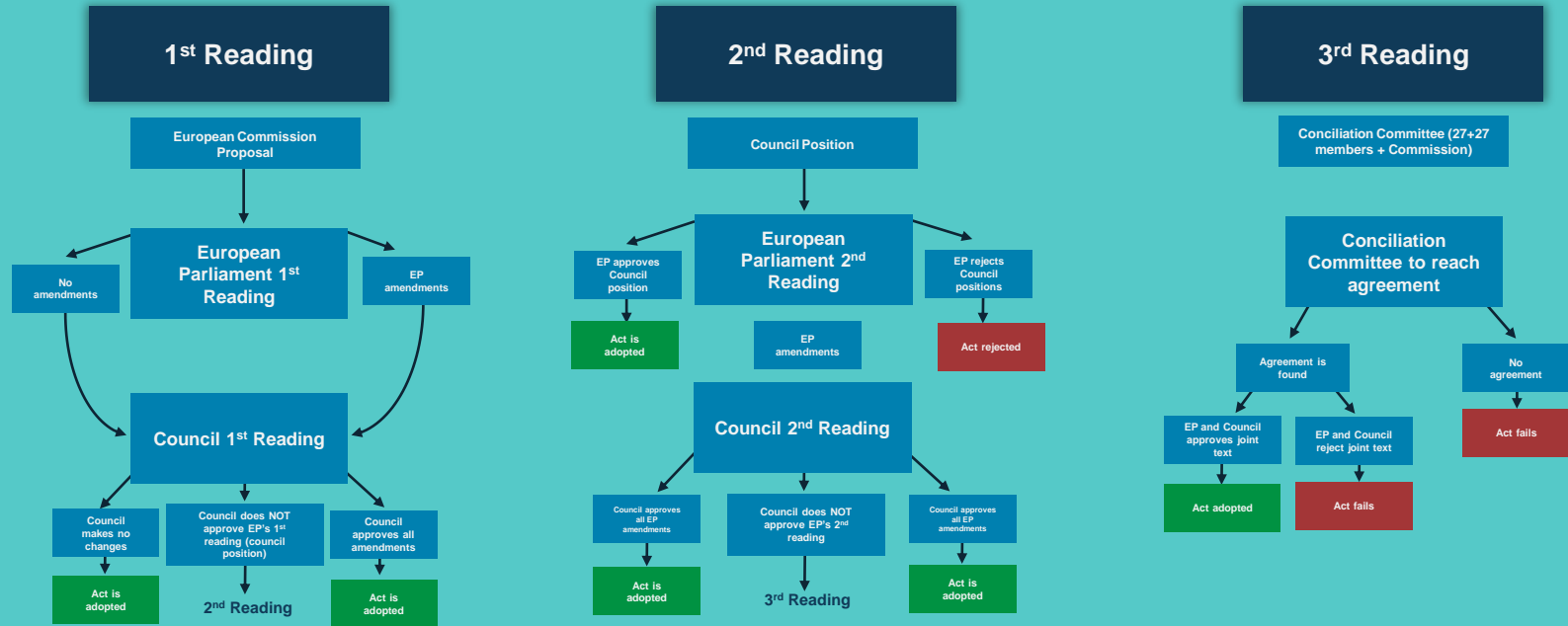

1. Drafting

Impact assessment by Commission of proposals, with an extended role for the **Regulatory Scrutiny Board**

2. Adopting

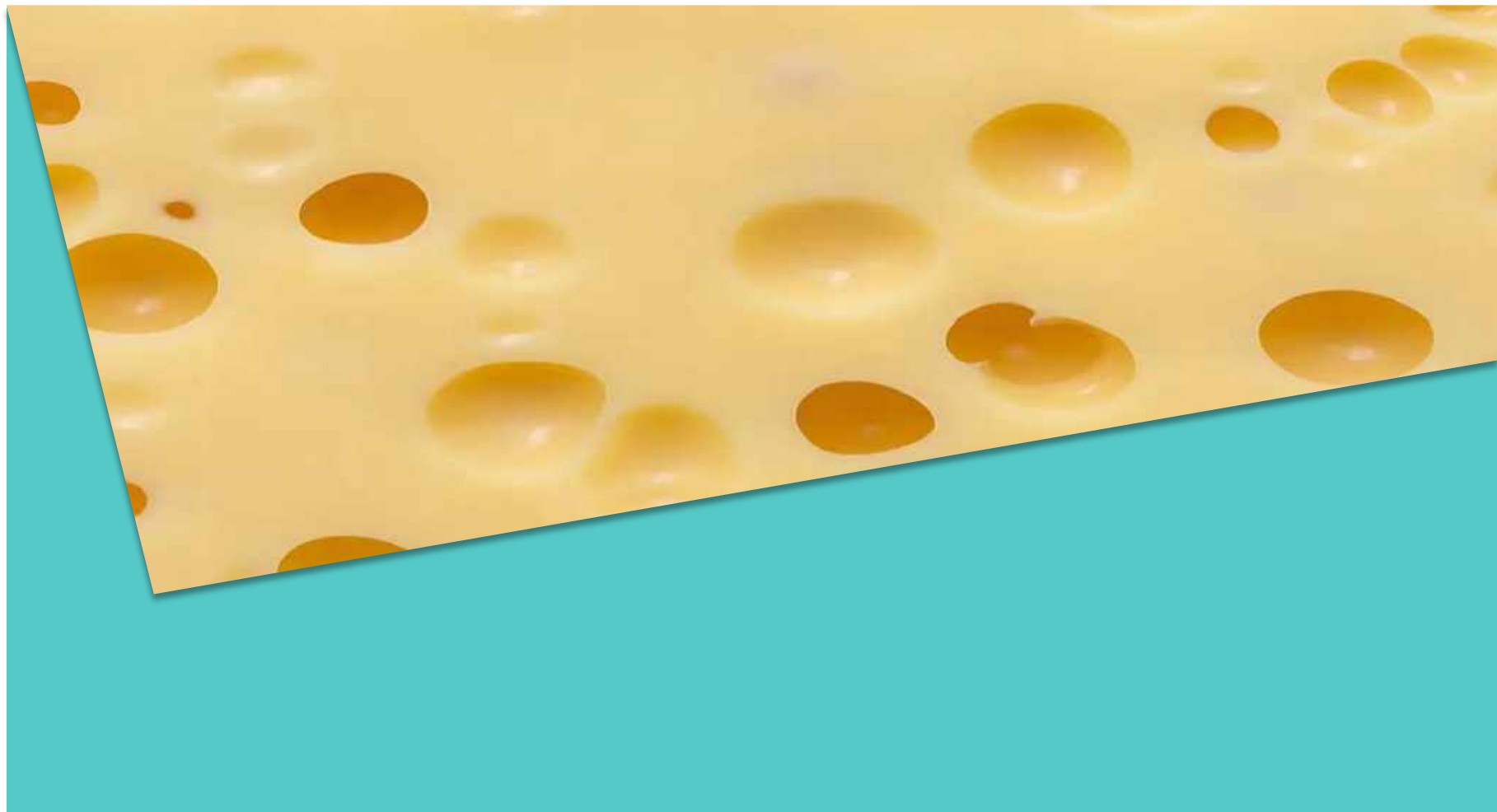
Ordinary legislative procedure: Impact assessments by European Parliament and Council and trilogues

Delegated and implementing acts:
Possible impact assessment, expert groups confirmed and public consultation

3. Implementation

Overall assessment of effectiveness of legislation: **REFIT actions, the REFIT Platform and the possible involvement of the Regulatory Scrutiny Board**

4. Ex post evaluation

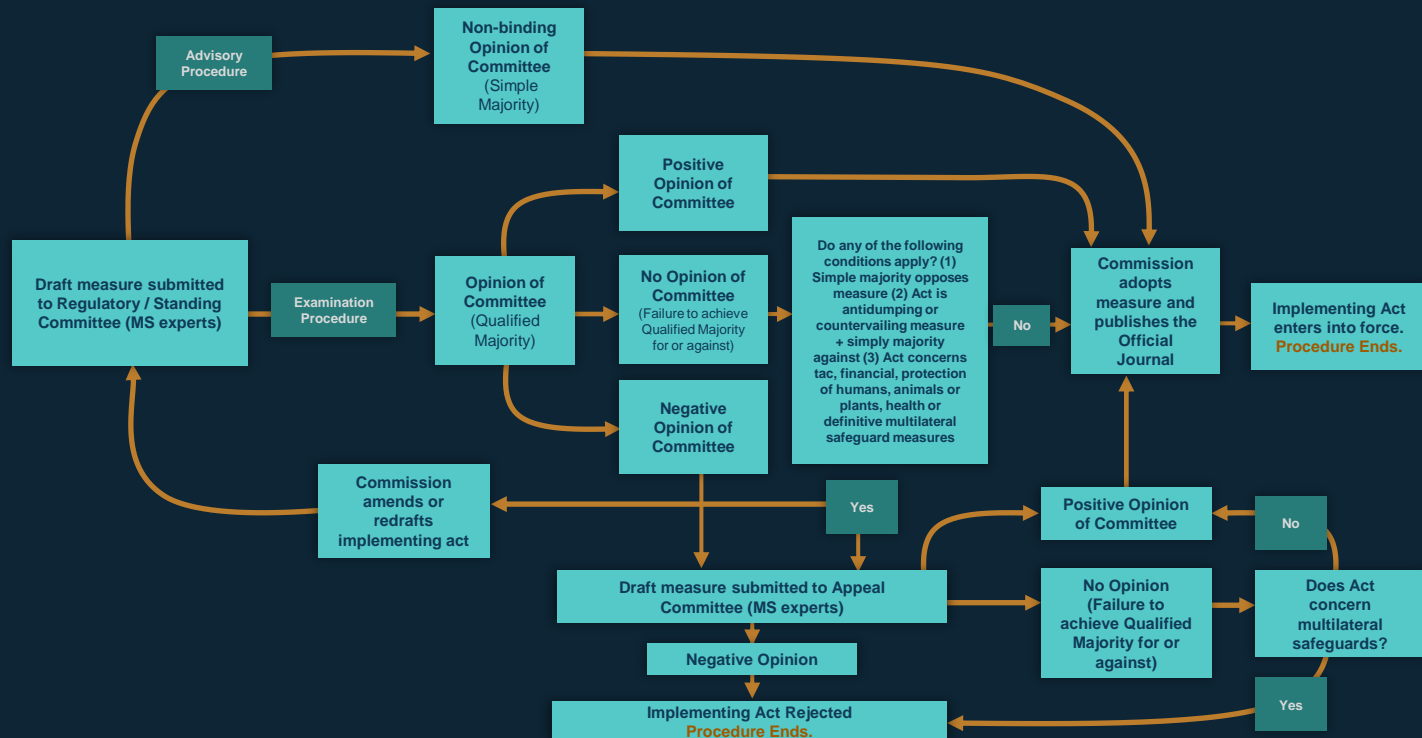
EXAMINATION PROCEDURE (I)



Derogations: (i) definitive multilateral safeguard measures requires + (ii) definitive draft anti-dumping countervailing measures may be adopted by simple majority until 01.09.2012

DIFFERENCES BETWEEN COMITOLGY COMMITTEES AND EXPERT GROUPS

Comitology has a limited scope: control of the implementing powers of the Commission

Comitology committees always created by the legislator

Comitology committees composed of all Member States

Opinions delivered by comitology committees have a direct impact on the decision-making process

Expert groups: advice and expertise to the Commission for the preparation of legislative proposals; policy initiatives and delegated acts, as well as for the implementation of existing legislation

Expert groups normally established by the Commission. In some cases – which should be the exception – set up by the legislator

Expert groups may be composed of individuals, organisation in the broad sense of the word and Member State's authorities

Opinions of expert groups cannot bind the Commission

REGULATION PROCEDURE WITH SCRUTINY (RPS)

Procedure for Regulatory Procedure with Scrutiny (Article 5a of Council Decision 1999/468/EC)

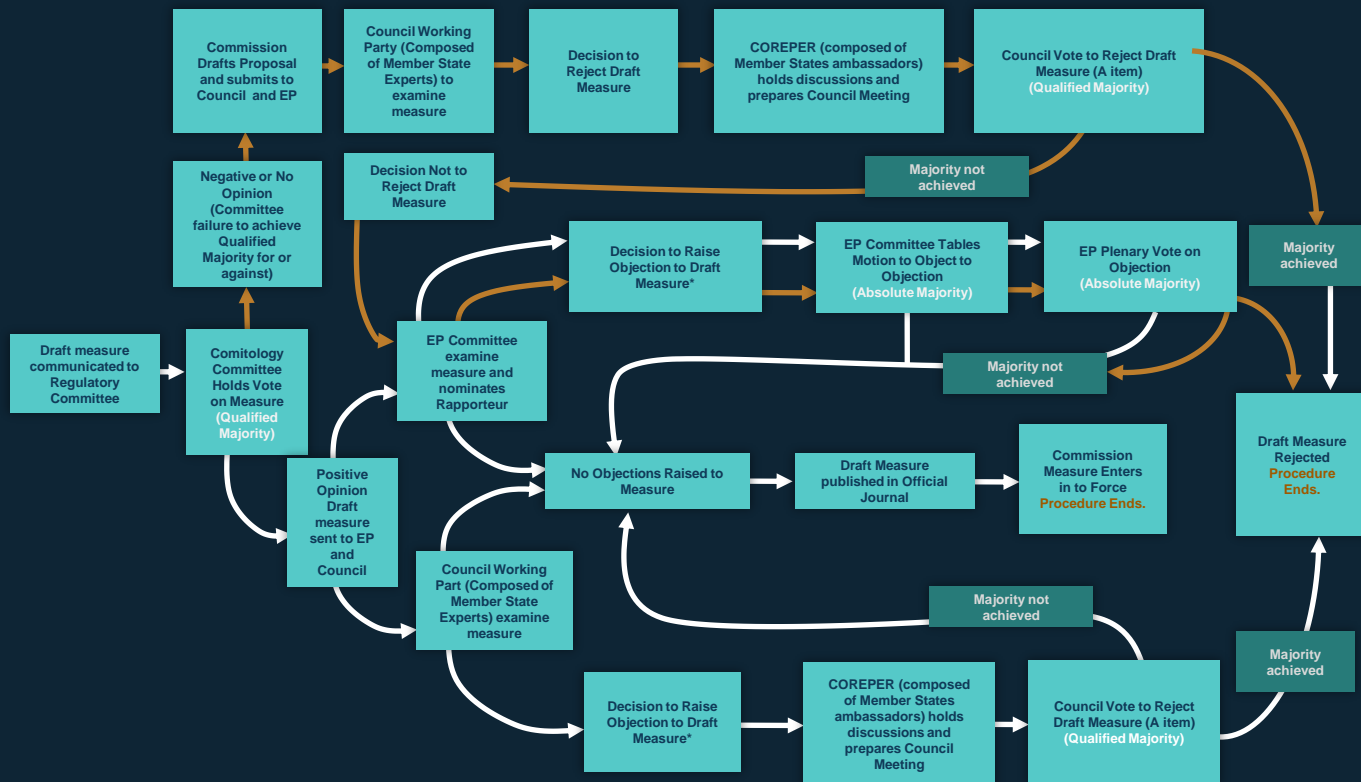
ORANGE: Council 2 months to act
EP 4 months to act from forwarding date of draft measure

WHITE: Council and EP have 3 months to act from forwarding date of draft measure

*Grounds for Objections

EP and Council can raise objections on the following grounds:

- (1) CEC exceeds implementing powers in parent measure
- (2) Draft measure is not compatible with aim or content of parent measure
- (3) Measure does not respect principles of proportionality or subsidiarity
