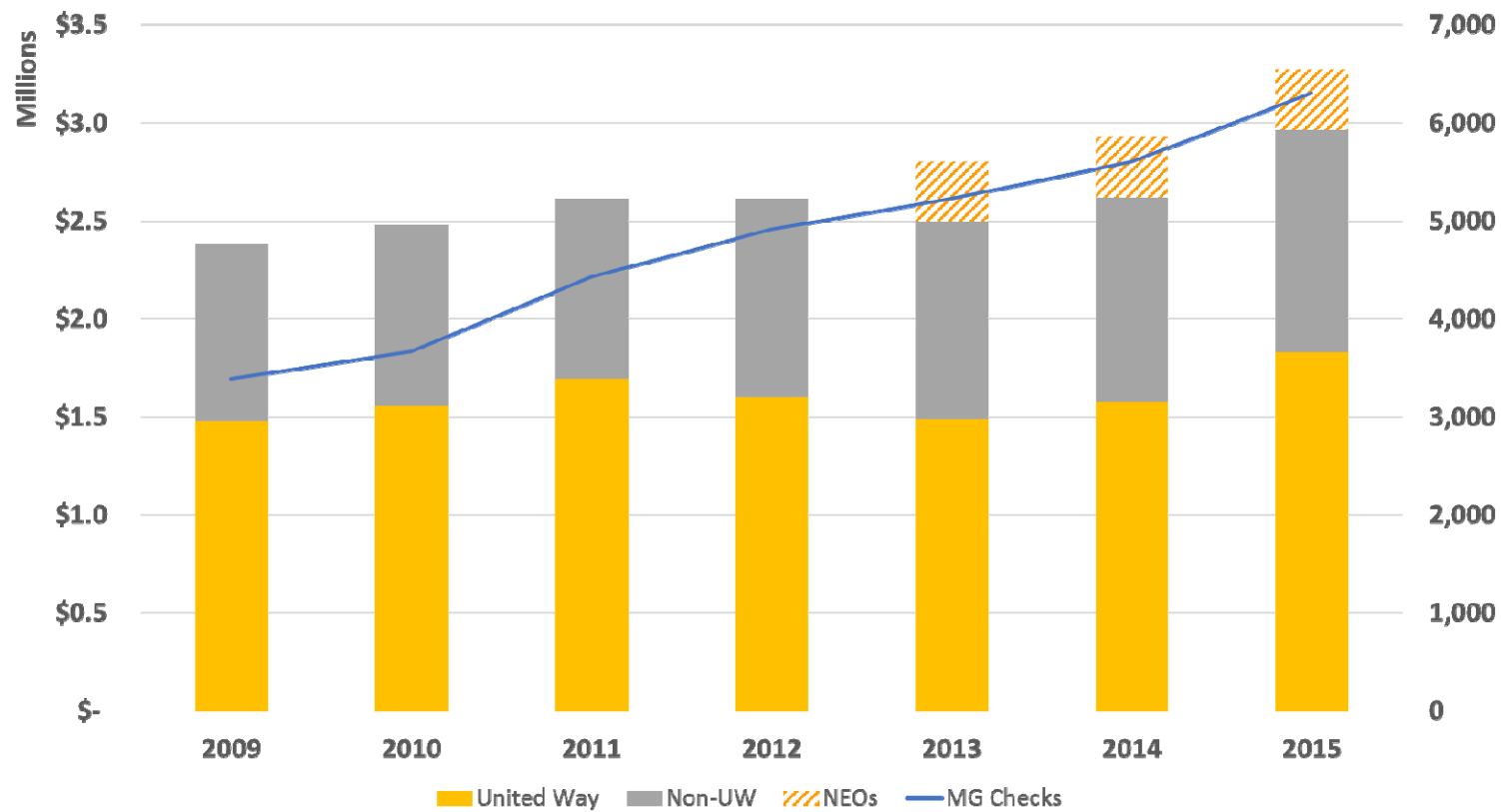

# Tracking for LD-203

*Excerpt from Matching Gift letter:*

Under the Lobbying Disclosure Act of 1995 (the “LDA”) Comcast may be required to report contributions to third parties, such as the Boys & Girls Clubs of King County, under certain circumstances. To help us comply with the LDA, please review and answer the following questions:

1. Is (or was) the Boys & Girls Clubs of King County named for, or established, maintained, financed, or controlled by, a Member or staff of the U.S. Congress, an Executive Branch official or a federal agency employee (“Federal Official”)?
2. Does (or did) a Federal Official maintain a position on the Boys & Girls Clubs of King County’s governing board?
3. Will this contribution be used for an event honoring or recognizing a Federal Official or for an event held by, or in the name of, a Federal Official?

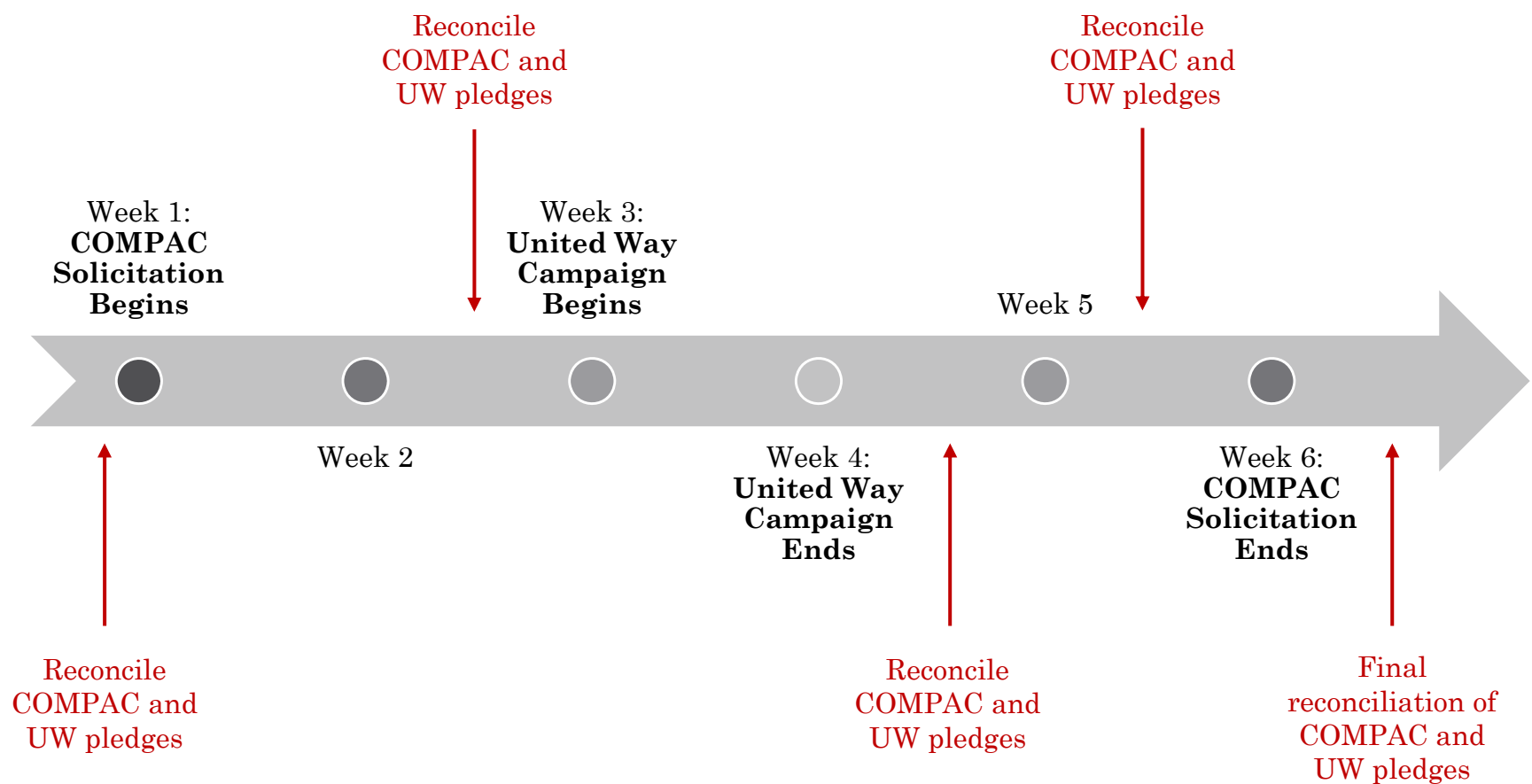

# COMPAC 2015 Success

- COMPAC Matching Gift dollars to United Way increased 10 percentage points over previous 5 years' average
- Correlated to increased giving to COMPAC: total raised increased 12.7%
- Overall United Way pledges increased over 11%
