


Political Action Committee Defined

- A Political Action Committee is when an interest group, union, or corporation wants to contribute to federal candidates or parties, it must do so through a PAC. These PACs receive and raise money from a "restricted class." The PAC may then make contributions to political campaigns.
- Cobham PAC is a voluntary contribution fund that supports members of Congress who are pro-business, pro-defense and pro-Cobham. The PAC is a strategic business development tool for Cobham North America.
- A PAC is a legal, transparent, federally-monitored means of expressing united interests with one powerful voice, representing many members.
- Corporations cannot contribute directly to federal candidates.







Main Legislative Issues

Sequester

Under the current law, more than \$100 billion in immediate, across-the-board cuts to discretionary programs and activities will go into effect each year shared equally by defense



FAA Reauthorization

The commercial aerospace industry needs a long-term FAA reauthorization which would provide structure and security for the industry. Policies like NextGen and UAV integration into commercial aerospace is important and needs to move forward. A long term bill as opposed to short term fixes will allow corporations the ability to plan

Export-Import Bank

The Ex-Im Bank supports businesses both large and small and includes export credit insurance, working capital loans, loan guarantees and project finance loans. The Ex-Im Bank also provides "express" export finance products which helps finance manufacturing exports within our industry which include large commercial aircraft, helicopters, general aviation aircraft, commercial satellites, and launch services. Reauthorization of the bank is critical for Cobham and our customers.

Tax Inversion Policy

Legislation to combat tax inversion have unintended consequences impacting U.S. subsidiaries of foreign parents like Cobham. If businesses can no longer deduct the interest it pays on its loans, the cost of capital rises, and for foreign companies deciding where to invest, America becomes even less attractive. Inversion policies need to be specific enough to not impact non-inverted foreign companies like Cobham.

Corporate Tax Overhaul

and succeed.

America has the highest corporate tax rate in the developed world which reduces investment in the U.S. and costs American workers jobs and higher wages. Tax reform is an important opportunity to make the U.S. significantly more competitive for all types of business investment, including vital foreign direct investment (FDI).

Timely Appropriations Process

In the absence of regular defense spending bills being passed,
Continuing Resolutions (CRs) have becoming business as usual.
Under a CR spending is capped at the prior year's level and there are no new starts for new programs. These short-term CRs bring a level of uncertainty that is harmful to the industry. We need yearly appropriations bills to pass to fund our troops at the appropriate levels.
