

What's Happening in Washington

February 17, 2017

Welcome to the first edition of Cobham & Congress, your bi-monthly update on what's happening in Washington, from the Cobham Government Relations (GR) Team. We look forward to keeping you up-to-date on political and policy activity relevant to our business.

Since the start of the 115th Congress and Trump Administration, the GR team has hit the ground running, establishing priorities for FY 18, and meeting with over 15 members of Congress and their staffs, and several industry partners, to advocate for our company. Some highlights include meeting with Rep. Higgens' (NY-26) Chief of Staff to discuss Orchard Park's priorities, talking to Sen. Moran (KS) about the FAA challenges facing our business, and hosting a meeting with Rep. Kuster (NH-2), to talk about our Exeter facility.

As far as a national budget is concerned, the defense industry remains in a holding pattern waiting for further information from Congress and the Administration. However, there have been plenty of ideas floated around both conferences about how to address defense spending going forward without coalescence around one particular plan (Omnibus, Continuing Resolution).

In mid-January, Senate Armed Services Committee Chairman, John McCain, issued a white paper which called for a five-year \$430 billion increase in defense spending. For Fiscal Year 2018, the recommended spending level for the defense base budget would be \$640 billion. That figure is \$54 billion above what the Obama administration had planned in its last five-year defense plan and does not include an additional \$60 billion for Overseas Contingency Operations. The proposed FY18 funding would be \$91.4 billion above the current Budget Control Act (BCA) caps. The Trump administration has stated they intend to draft an emergency defense supplemental for FY2017 with a target of at least \$18 billion, which will likely be submitted by March 1st. All services have revised their unfunded requirements documents in light of this news. It is thought that most of the funding that was stripped from the final FY2017 National Defense Authorization Act will be funded through the supplemental. However, adding funding to build President Trump's wall on the Mexican- American border might delay or derail passage of the defense supplemental.

Beyond the supplemental, the appropriations committees must also finalize their spending bills for FY2017. The current continuing resolution expires on April 28, 2017, though neither party seems to know the likely outcome of the FY2017 bill process. Some have indicated a year-long CR and others have said that the defense bill will get a separate vote and that the rest of the 11 appropriation bills will be on a full year CR. House Armed Services Chairman Mac Thornberry stated yesterday that he doesn't expect lawmakers will support a continuing spending resolution to fund the Pentagon through the remainder of the year.

While President Trump has largely put in place his Cabinet and top Senior Officials, albeit at a historically slow pace, upset came less than a month into the Administration with the resignation of National Security Advisor Michael Flynn this week, due to scandal over his Russian contacts. Some of President Trump's confirmed Cabinet Secretaries include Defense Secretary Jim Mattis, VA Secretary David Shulkin, Department of State Secretary Rex Tillerson, Homeland Security Secretary John Kelly, Treasury Secretary Steven Mnuchin, HHS Secretary Tom Price, Education Secretary Betsy DeVos, Transportation Secretary Elaine Chao, Attorney General Jeff Sessions, and CIA Director Mike Pompeo.
