- Average Contribution: \$14 per payroll deduction

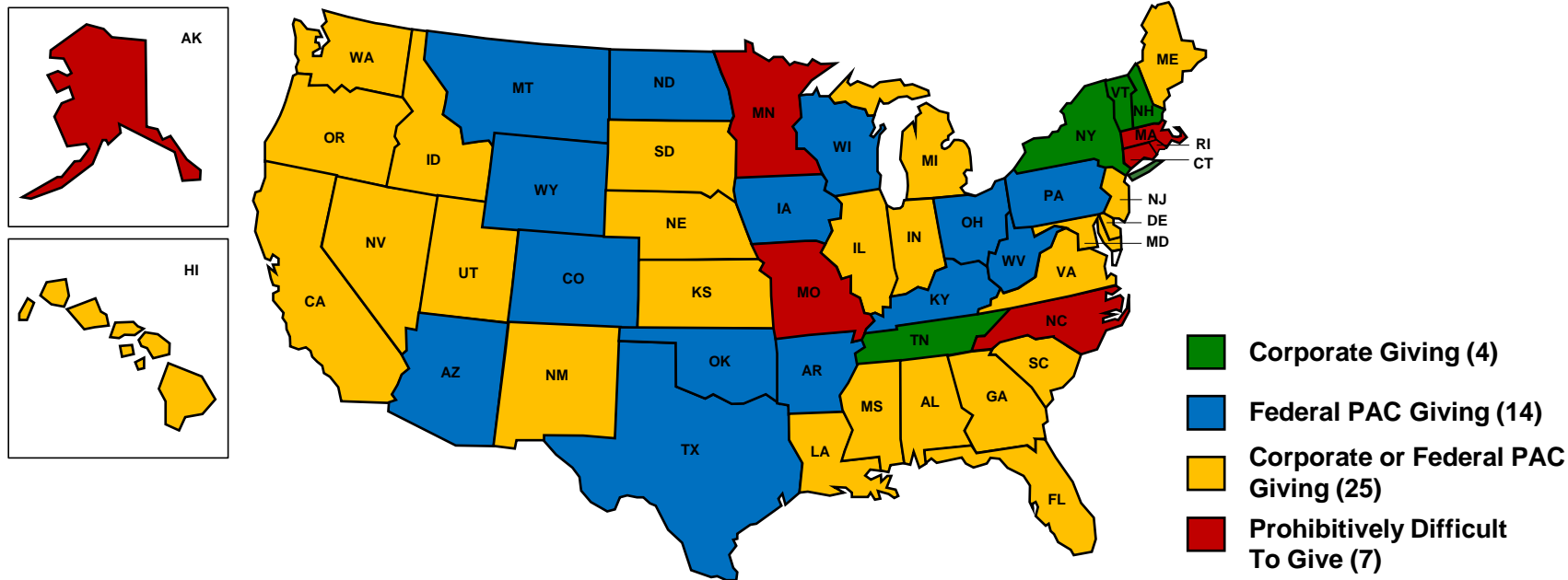


2018 PAC and Corporate Disbursements

- **\$190,000** in PAC Revenue
- **\$230,000** in PAC Disbursements
 - **\$210,000** Federal, **\$20,000** State (6 States)
- **\$75,000** State Level Corporate Contributions (13 States)



State Political Contribution Map

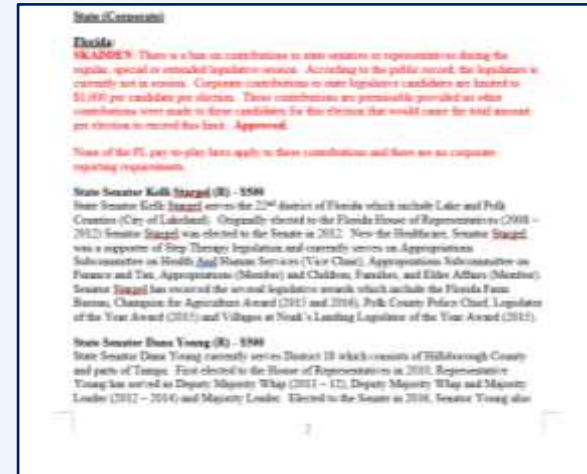

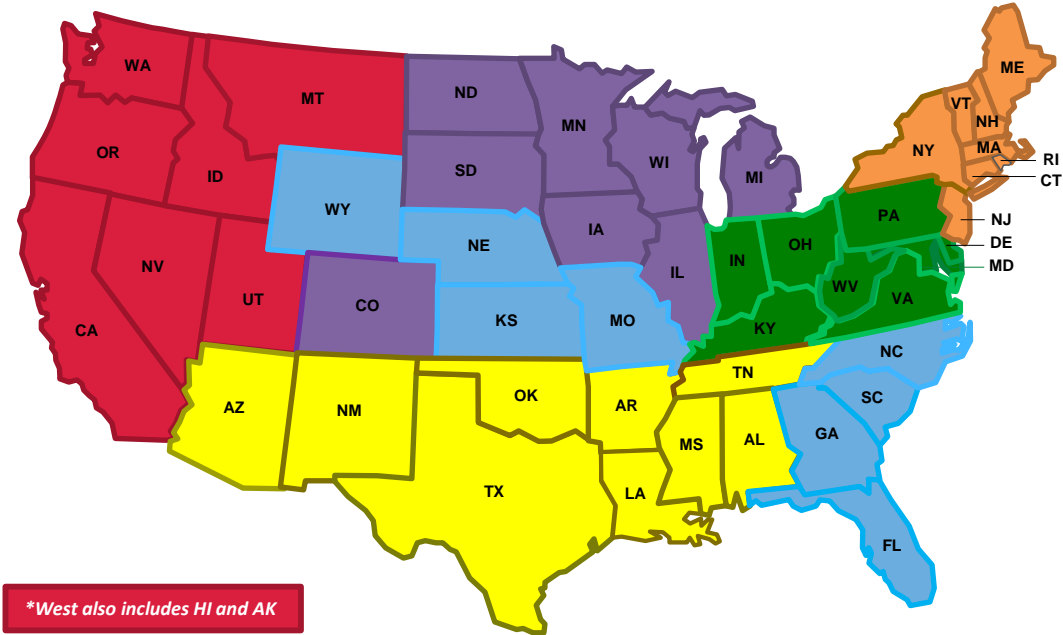
PAC & Corporate Budgeting and Approval



- Celgene PAC Board Consists of 9 Standing Members and 3 Rotating PAC Ambassadors From Different Company Functions
- Topline State Giving Plan Approved by Board During Annual Planning Meeting Followed by Monthly Requests for Contributions to Individual Members
- Budgets & Contribution Justifications Submitted by Regional State Government Relations Directors and Vetted by SGR Lead
- Before Submitted to PAC Board, all State Contributions Requests Reviewed and Pre-Cleared by Legal Counsel (Thanks Melissa!)
